MEETING

1. Open the meeting - Rich Warner opened the meeting at 6:56 p.m.
2. Review/approve minutes of August 4, 2020 - Marti and Terry each had corrections to be made to minutes. Edits to be made and minutes resubmitted.
3. Health Agent Report: Randy C or Lisa DB - Randy reported -
 1. Last couple of weeks relatively quiet. Emailed information for service on 89 State Street but has received no confirmation of service.
 1. Marti received emails/invoices for service: \$34/mailling + \$37.76/notice fee= \$71.76/total. Served by by Deputy Sheriff at 4:20 p.m. on August 11, 2020.
 2. Regarding Floodwater Brewery, a food truck would fit the requirement of food prepared on site.
4. School re-opening - MTRSD plan: discussion -
 1. Rich attended the school committee meeting (remote). The school reopening plan supports the first three months being remote, with an end date of November 24 at which time the format will be re-examined.

2. Students with an IEP will have special arrangements made if in person needs must be met.
3. For students with no internet access, hubs are being created (schools, churches, etc) where internet is available and may be accessed by multiple students. Discussion followed on managing students in hub locations. Lisa White is working with Sue Mitchell, and Randy is working with Sue and MTRS superintendent. There will be multiple hubs in an effort to serve families as close to home as possible.
5. LUA - 61 Purinton Rd. Review, approve, y/n - Board reviewed.. Terry moved to approve LUA regarding septic system. Marti seconded. Vote in favor of motion was unanimous.
6. Streetlight replacements - discussion.
 1. Terry and Marti had driven through town after installation of the new street lights; Terry in very early morning hours, and Marti on a dark and rainy evening. Both shared their observations. Board discussion followed including dimming, comparison to old lights, shields, energy usage, cost, and discussion at select board meeting.
 2. Randy suggested using a light meter to obtain a reading on the Shelburne side of river, then compare to a reading from Buckland side.
7. COVID-19; Updates/issues/developments -
 1. Flu clinic still set for Oct. 17, 2020. Scheduled as a two hour clinic, but could be longer depending on turnout.
 1. MAPHCO ordered vaccine refrigerator.
 2. Senior Center is not hosting a clinic this year which could increase time frame of Buckland's clinic.
 3. Discussed format, flow for entering and exiting to keep cars from backing up on Rt. 112. Also, a pull out lane is provided for persons in cars to fill out paperwork.
8. Review/process mail; Marti or Terry will collect from Town Hall - Mail opened and processed; Septic pumping documents.
9. Any other items not reasonably anticipated by Chair 48 hours prior to meeting -
 1. Herb Guyette and Marti received emails from Dena reporting an odor (oil? gas?) at the base of Cross Street. Horace and Marti went to investigate and found no odor at that time.
 2. Information received from animal control about suspicious skunks on Crittenden Hill . None captured or tested. Reported to animal control officer.
 3. Per Chief Hicks, there has been no response to request for extra police coverage using CARES money because it does not pay detail wages or overtime. Marti gave Chief additional signs regarding masking.
 4. BOH will not meet on Sept 1, voting day. Will return to once per month meetings on third Tuesday. Next meeting on September 15, 2020 at 6:30 p.m.
