- 5. Update on past Green Communities Grant applications; planning for 2019
 continue discussion on potential projects to include in future applications, especially those that will bring us closer to the 20% reduction in energy use marker
 DOER updates?
 - ° July '18 GCG: \$27,707 for removable window inserts for most windows at Town Hall and Police Station: Farnum insulation (VT) is making inserts, possible installation in February. Once finished, need to complete close-out paperwork/process before we can apply for new grant.
 - Opening that FRCOG will continue have the grant that supports help which Buckland has gotten with closeouts and annual reporting on Green Communities Grants already received, plus application for future grants, procurement, and bidding (cost of administrative services built into GCG application)
 - ° Need to find out more about Buckland's progress toward goal of 20% energy-use reduction, and how town garage move affects the figures.
