° Folks from Revise went to door to door to share information on Mass Save Home Energy Audits and services.

° *See Attached Fliers (4 pages)* Now, Eversource has decided to hold special event for small businesses during last 2 weeks of August, in both Shelburne and Buckland: Darek Chomiak – from the chosen vendor "Energy Resources" – will be going door to door to businesses in both towns to see if they want to participate in getting an energy assessment – and energy efficiency upgrades usually offered at a 70% discount, will be offered at up to 90% discounts during these 2 weeks. There's also a better incentive for insulation for renters (probably need to coordinate with landlord and Cynthia could help bridge that gap). Darek can prescreen ask questions over the phone – people can make appointments. If landlord has done MassSave energy audit – different incentives for landlords & renters – it's the occupant of the building that this program is dealing with.

Also town farms – not just electrified buildings – may benefit from this program. Houses of worship and non-profits are also included. If they have questions, they can get in touch with Cynthia.

° Suggest to Cynthia that she contact Buckland Town Clerk to see if she can provide her with a list of Buckland businesses. Also, suggested that she send information to Heather, and inquire about possibility of including the info in Town News. ° Harvey will distribute fliers to businesses on Bridge St, after Cynthia gets copies to him

° There's lots of interest in mini-splits, but that's not part of this program (Energy Resources does mini splits as an extra piece... could find out if appropriate by contacting Darek Chomiak


