Suggested that Tom contact Heather for detailed information on the process, subsequent energy usage, community response.

° Discussion about derailments, especially those involving hazardous materials: future preparations/precautions plus discussion of experiences around December 2016 derailment at Elm Street/Ashfield Street crossings. Particular concerns about possible derailments involving hazardous chemicals and radioactive materials. Hopefully local towns can work together to detect and mitigate hazards as well as respond to future events.

-- Advocate for CXS to be required to report all derailments, even if it involves just 1car.

-- Find out when Buckland's *Hazardous Mitigation Plan* will be updated (MO): propose amendment to include exit plans for residents on dead end streets

-- Contact FRCOG to find out about local resources related to derailments (MO)

-- Get more information on Buckland's current resources for dealing with derailments and events involving hazardous materials (PN, MN)

° Contact Cynthia Boettner to find out how their recent MassSave program went. (M0)
