MEETING

- 1. Meeting opened at 6:37 p.m.
- 2. Continue discussion with Alyssa Larose, FRCOG, Re: Housing Alyssa gave a hand out, "Village Residential Cluster Development", which was a first draft for the purpose of discussion only. The meeting focused on village cluster development and included discussions on:
 - 1. Comparison of types of building codes (i.e., HUD vs MA building code for frame built homes), also comparison of energy efficiency of each.
 - 2. Discussion also of mobile and modular homes.
 - 3. Examples given of cluster developments in area towns, and how Shelburne is approaching the issue.
 - 4. Questions raised:
 - 1. How does development happen?
 - 2. How is developer attracted? Incentives?
 - 3. Discussion followed.

- 5. Open space requirements triggered extended dialogue regarding its use, public access, maintenance, under whose control/ownership it would be, and the possibility of increasing it from 20 to 30% as suggested by Brian.
 - 1. Many creative ideas were offered for ways the open space could benefit the community and/or the cluster development such as community gardens, ground mounted solar for use by the development (John commented that existing solar bylaws may have to modified to allow for that use of open space).
 - 2. Alyssa drew a sketch of a hypothetical cluster development to illustrate how everything might fit into the one parcel of land:
 - 1. Starting with the initial entrance to the development.
 - 2. The roadway off from which each individual lot/unit was accessed.
 - 3. The open space parcel, which must be a contiguous piece of land.
- 6. Next affordable housing meeting scheduled for July 30, 2019 at 6:30 p.m. Short discussion on other possibilities to meet criteria of affordable housing. Andrea asked where she could find helpful information to further educate herself on the subject of affordable housing.
- 3. Review and approve meeting minutes Minutes were reviewed by board members. Andrea moved to approve. Brian seconded the motion. Vote to approve was unanimous.
