Meeting

Meeting was called to order at 5:31 p.m. by Ms. Willmore

Local Rapid Recovery Grant application - Ms. Butler introduced the premise of the grant, stating that it would not provide monetary funds, but would support a consultant to work with the community to provide rapid recovery resources, and an action plan for downtown. The grant application was written by Andrew Baker and John Taylor of the Shelburne Select Board, but is a joint endeavor including the Town of Buckland. During an informative brainstorming session held for the public to weigh in, the focus of Buckland and Shelburne was clear. Buckland's priorities lean more toward planning for capital improvements such as downtown bathrooms, street scape, improved parking,

and other infrastructure improvements. Shelburne focused more on revitalizing the partnership, marketing and promotion. Whit Sanford emphasized the advantage of a Buckland and Shelburne collaboration, noting the benefits of working together. When asked for any additional comments, Mr. Turner stated he agreed with Buckland's proposals during the brainstorming session, to which Mr. Del Castillo agreed and had no further comments. Mr. Turner moved to support the Local Rapid Recovery Plan, seconded by Mr. Del Castillo. Vote: Turner, yes; Del Castillo, yes; Willmore, yes.
