Meeting

The meeting was opened at 5:01 p.m. by Ms. Willmore, Chair.

Appointments

5:00 p.m. Mosquito Spraying, Board of Health, CPHS - Ms. Willmore asked if anyone wished to speak regarding the PV Mosquito Control District. Janet Sinclair stated that joining/not joining the district would have to be voted on at Annual Town Meeting(ATM), and deadline for opting in/out of State spraying is prior to ATM. Discussion by Board members, BOH, CPHS and public included:

- If Buckland opts out of state spraying, does it have the people power to execute a plan of their own?
- Concerns expressed about spraying with no studies on efficacy.
- Deadline for opting out of state spraying has been extended from May 15 to May 28.
- Lisa Danek Burke, FRCOG Health Agent, read an email from the EEA and gave link to view data on surveillance and spraying. Marti Taft Ferguson of the BOH could not find surveillance data on the site and noted there is no evidence that the state is monitoring Buckland. Without surveillance, there is no data. Ms. Danek Burke agreed that there is no clear way to obtain 2020 data.
- CPHS towns in the mosquito control district are Bernardston, Leyden, Heath, Rowe, and Deerfield. Greenfield opted out of state spraying; Heath and Deerfield not recommending opting out.
- What are the triggers to spraying? What is the process and what are the risks?
- Currently, mosquito district offers only surveillance and testing in addition to 2 traps which are monitored weekly. Also, if town wishes to use larvicide, district can offer help in purchasing.
- Services must be weighed against cost.
- As part of district, town is still responsible for mitigation.
- District information does list future services but current status of them is unknown.
- Though occurrence of West Nile Virus and EEE is rare in this area, mortality statistics were compared with COVID. COVID, 2% while EEE is 30-50%.
- Ms. Ferguson of the BOH recommends proceeding with opting out of state spraying.
- BOH to attend next Select Board meeting on May 25 with opt out/alternate plan.

Regular meeting resumed at 5:48 p.m.

<u>Annual Town Meeting Warrant</u> - Annual Town Meeting date set for June 5, 2021 at 10:00 a.m. in the parking lot of Mohawk Trail Regional High School. Rain date options were discussed based on the availability of Mohawk venue and various persons involved in town meeting(Select Board Members. Town Clerk, Moderator, etc.). Following Board discussion of possible dates, and the suggestion to move the meeting indoors, a June 26 rain date was ultimately decided upon.

Board members addressed each of the 28 warrant articles with Ms. Butler answering questions and offering clarity when needed. Mr. Del Castilho called attention to some grammar, punctuation, and wording errors in the Dog Bylaw. Because joining the Mohawk Trail Woodland Partnership is not an option this year and that further public education is needed, it was decided to replace that article, #26, with an article on voting to join the Mosquito Control District. After discussing Articles 1-26, Petition Articles #27 and #28 were covered. Mr. Del Castilho stated they were not written in proper format and questioned if the state Attorney General's office would reject them if passed. Ms. Butler replied that the AG's office would edit. Mr. Turner moved to accept the warrant as written and amended, seconded by Mr. Del Castilho. Vote: Turner, yes; Del Castilho, yes; Willmore, yes.

Logistics of ATM discussed including public address/technology provider and a portapotty being delivered on June 4.

<u>Regional Shared Services</u> - Mr. Turner reported that he has received some responses to his survey of area towns, but not as many as he anticipated; he would like to wait another few weeks in hopes of more results. It appears that so far most towns want to share equipment and floater staff like police and highway department personnel. To be continued as more surveys are received.

<u>Juneteenth</u> - How to recognize Juneteenth was discussed including whether or not it should be a paid holiday for employees. The possibility of exchanging it for a currently paid holiday was suggested, and Ms. Butler was asked if there had been any discussion by Town Hall staff. She reported that there would be a staff meeting on Thursday, May 13, and that would be on the agenda. Juneteenth will be addressed at the next Select Board meeting.
