1. Appointments

5:30 p.m., Jan Ameen – Franklin County Solid Waste Management District – Jan Ameen indicated she was meeting with Select Boards about Solid Waste District's services (attached); there are administrative assessment based services and fee for services. Jan Ameen indicated she applied for a paper compactor and was awarded \$7,500 toward the \$15,000 total expense; will save money for the Town's hauling costs. She indicated there are two more years on the current recycling contract; we are one of the few parts of the State that gets paid for their recyclables; this money could be used toward our share of the cost of the paper compactor. She spoke of programs where the Town could earn points for various recycling activities (i.e., a swap shed).

a. Notification of Town Officials – Selectmen's Policy – Kevin Fox moved we approve the Town of Buckland Order of Notification Policy; Zack Turner. VOTED unanimously in favor.

b. Highway Garage Engineering Proposals/Interview Results – Request for Price Proposal – Dena Willmore reported that last night the Highway Facility Committee and Selectmen interviewed three firms. After discussion, those present rated them in the following order: Roy S. Brown Architects, Jones Whitsett, and Bayside Engineering. Kevin Fox suggested checking references before asking for a bid proposal. Discussion regarding setting Special Town Meeting date. Decided to push out until January; Dena Willmore will check references. Dena Willmore suggested asking for the fee proposal by December 8. Decided to sign the Special Town Meeting Warrant and pass over Article 1. Zack Turner moved to sign the Special Town Meeting Warrant for December 21, 2017; Kevin Fox seconded. VOTED unanimously in favor.

Zack Turner moved we accept the recommendation of the Highway Facility Committee and go into negotiations with Roy S. Brown Architects; Kevin Fox seconded. **VOTED** unanimously in favor.

c. <u>Comcast/MBI Update</u> – Dena Willmore indicated Comcast is waiting for four poles to be put in by Verizon which is delaying finishing the work of Comcast who has all the materials at the ready.
