Zack Turner opened the meeting at 5:30 p.m..

1. Appointments

5:30 p.m., Jan Ameen, Franklin County Solid Waste Management District – Jan Ameen reported that letters to gauge interest have gone to area restaurants regarding the compost dumpster. The Solid Waste District will monitor the dumpster and billing.

Discussion about pay-as-you-throw bags *ms.* stickers. Town bags are one color which makes it easier for the Attendant to distinguish. Some towns use punch cards which makes more work for the Attendant. Many towns use stickers (about \$.05 each) which go on the top of the trash bag; residents could use feed, grain bags for their trash. Residents would need clear instructions as to what one sticker covers; people will use the biggest bag they can. The attendant would have to check each bag; our transfer station is spread out. Town trash bags cost \$.20 each. Suggested using the kitchen-sized bag stock up. Jan Ameen reported the new compactor will be arriving soon.
