2. Agenda Items

- a. Fiscal Year 2020 Budget Update Bob Markel reported the budget is taking shape; perhaps take Stabilization funds for Highway projects; put some funds toward OPEB study. Budget looks balanced and needs met. Dena Willmore moved we end funding for the Partnership; Zack Turner seconded. VOTED unanimously in favor. Regarding three successive year audits to get a bond rating for the Highway Facility Project, Bob Markel indicated the audits cost \$16,000 per year; need \$24,300. Scanlon Associates can do two audits simultaneously in July.
- b. <u>Update on Town Administrator Search</u> Position being advertised. Screening Committee will meet on April 4, 2019, to review applications.
- c. <u>Mowing Bid</u> Dena Willmore moved to accept the mowing bid presented by Canepari Landscaping; Barry Del Castilho seconded. Dena Willmore yes, Barry Del Castilho yes, Zack Turner no.
- d. Special Town Meeting Warrant Some items were eliminated from the draft as expenses can be covered through transfers. Decided to place Marijuana By-Law on Annual Town Meeting warrant. Andrea Donlon indicated the Planning Board could do a power point presentation regarding the proposed by-law. Discussion about having Annual Town Meeting on Saturdays. Barry Del Castilho moved we remove the Zoning By-Law change from the Special Town Meeting Warrant; Dena Willmore seconded. VOTED unanimously in favor.

1. Appointments

Efforts for New Pool – Cindy Schwartz indicated the new playground was installed last summer; the pool house was refurbished and will better suit the Summer Camp Program. Fields were refurbished at the Rec and Cricket Field; many thanks to Franklin County Tech School. Regarding the new road at the Rec, the wiring will go underground; in contact with the contractors. Carol Foote indicate the Rec Committee is in a place to prepare for the pool project; putting together materials for a campaign and would like the support of the Town. Zack Turner moved to support the Recreation Committee, and the Recreation Committee be the fundraising arm on behalf of the Town for the Buckland Recreation Area pool; Dena Willmore seconded. VOTED unanimously in favor. Dena Willmore indicated she asked for an earmark with Senator Hinds and Representative Blais. The Open Space Plan is being updated with assistance from FRCOG. Bob Markel is meeting with FRCOG on March 19, 2019.
