**ARTICLE 2: REPORTS OF TOWN OFFICERS**

To see if the Town will vote to accept the **Reports of Town Officers**; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to accept the reports of the Town Officers as printed in the **2020 Annual Town Report**.

**ARTICLE 3: SALARIES OF ELECTED OFFICIALS**

To see if the Town will vote to raise and appropriate, or otherwise provide a sum of money for [Elected Officials' Salaries](#) for Fiscal Year 2022, as line item appropriations, as recommended by the Finance Committee in the Town of Buckland Fiscal Year 2022 Operating Budget Report; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to raise and appropriate from available funds the sum of **\$42,715** for elected officials' salaries for Fiscal Year 2022, as line item appropriation, as recommended by the Finance Committee in the Town of Buckland Fiscal Year 2022 Operating Budget Report.

#### ARTICLE 4: TOWN OPERATING BUDGET

To see if the Town will vote to raise and appropriate, or otherwise provide a sum of money to fund the [Town Operating Budget](#) for Fiscal Year 2022, as line item appropriations, as recommended by the Finance Committee in the Town of Buckland Fiscal 2022 Operating Budget Report; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to raise and appropriate from available funds the sum of **\$1,856,499** for the Town Operating budget for Fiscal Year 2022, as line item appropriation, as recommended by the Finance Committee, in the Town of Buckland Fiscal Year 2022 Operation Budget Report.

#### ARTICLE 5: SPECIAL LINE ITEMS

To see if the Town will vote to raise and appropriate, or otherwise provide a sum of money for the purpose of funding [Special Line Items](#) in the Town Operating Budget for Fiscal Year 2022, as line item appropriations, as recommended by the Finance Committee, in the Town of Buckland Fiscal Year 2022 Operating Budget Report, and, further to authorize that unspent amounts in said line items may be carried forward for use in following fiscal years without further appropriation; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to raise and appropriate from available funds the sum of **\$89,350** for the purpose of funding Special Line Items in the Town Operating Budget for Fiscal Year 2022, as line item appropriation, as recommended by the Finance Committee, in the Town of Buckland Fiscal Year 2022 Operating Budget Report, and, further to authorize that unspent amounts in said line items may be carried forward for use in following fiscal years without further appropriation.

#### ARTICLE 7: MOHAWK TRAIL SCHOOL DISTRICT CAPITAL ASSESSMENT

To see if the Town will vote to raise and appropriate, or otherwise provide a sum of money for the [Mohawk Trail Regional School District Capital Assessment](#) for Fiscal Year 2022; or take any action relating thereto.

Motion: Ms Moderator, I move that the Town vote to raise and appropriate from available funds the sum of \$99,739 for the Mohawk Trail Regional School Distict Capital Assessment for Fiscal Year 2022.

**ARTICLE 8: MOHAWK TRAIL SCHOOL DISTRICT NEW DEBT – BUCKLAND SHELBURNE ELEMENTARY SCHOOL**

To see if the town will vote to allow the [Mohawk Trail Regional School District to borrow a sum of money, not to exceed \\$382,850 for work at Buckland Shelburne Elementary School](#) in Shelburne, Massachusetts, to include rebuilding or resurfacing of parking lots and certain walkways; replacement of the fire alarm control panel and related sensors; replacement of a pneumatic heating control system; replacement of a heating system boiler and domestic hot water tanks; and replacement of restroom exhaust fans; and including costs incidental or related thereto, which purpose of the projects will materially extend the useful life of the school and preserve the asset capable of supporting the required educational program. Said sum is to be expended under the approval of the School Committee's Building Subcommittee, and to meet said appropriation, the District Treasurer, with the approval of the Chair, is authorized to borrow said sum under MGL Ch. 44 or any other enabling authority. This borrowing shall be subject to and contingent upon an affirmative vote of the Town to exempt its allocable share of the amounts required for payment of interest and principal on said borrowing from the limitations on taxes imposed by M.G.L. 59, Section 21C (Proposition 2½), or take any action relating thereto.

To see if the town will vote to allow the [Mohawk Trail Regional School District to borrow a sum of money, not to exceed \\$665,000 for work at Mohawk Trail Regional School](#) in Buckland, Massachusetts, to include replacement of the heating boiler control system; resealing of parking lots; replacement of the fire alarm control panel and related sensors; replacement of/upgrades to certain domestic hot water heaters, condenser units, heating system hot water control valves, and freeze prevention system; construction of a second means of egress from the main electrical switchgear room; installation of additional safety railings to sections of the outside bleachers; replacement of the movable gymnasium partition; and replacement of floor covering in the library; and including costs incidental or related thereto, which purpose of the projects will materially extend the useful life of the school and preserve the asset capable of supporting the required educational program. Said sum is to be expended under the approval of the School Committee's Building Subcommittee, and to meet said appropriation, the District Treasurer, with the approval of the Chair, is authorized to borrow said sum under MGL Ch. 44 or any other enabling authority. This borrowing shall be subject to and contingent upon an affirmative vote of the Town to exempt its allocable share of the amounts required for payment of interest and principal on said borrowing from the limitations on taxes imposed by M.G.L. 59, Section 21C (Proposition 2½), or take any action relating thereto.

#### **ARTICLE 11: FRANKLIN COUNTY TECHNICAL SCHOOL OPERATING ASSESSMENT**

To see if the Town will vote to raise and appropriate, or otherwise provide a sum of money for the [Franklin County Technical School Operating Assessment](#) for Fiscal Year 2022; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that Town vote to raise and appropriate from available funds the sum of **\$111,754** for the Franklin County Technical School Operating Budget, as a line item appropriation, as recommended by the Finance Committee in the Town of Buckland Fiscal Year 2022 Operating Budget Report.

#### **ARTICLE 12: FRANKLIN COUNTY TECHNICAL SCHOOL CAPITAL ASSESSMENT**

To see if the Town will vote to raise and appropriate, or otherwise provide a sum of money for the [Franklin County Technical School Capital Assessment](#) for Fiscal Year 2022; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to raise and appropriate the sum of **\$5,789** for the Franklin County Technical School Operating Budget, as a line item appropriation, as recommended by the Finance Committee in the Town of Buckland Fiscal Year 2022 Operating Budget Report.

**ARTICLE 13: SHELBURNE FALLS WASTEWATER TREATMENT FACILITY BUDGET**

To see if the Town will vote to raise and appropriate, or otherwise provide a sum of money to fund the [Operation and Maintenance of the Shelburne Falls Wastewater Treatment Facility](#), an Enterprise Fund, for which a sum of money will be raised from anticipated receipts from the Buckland user assessment as a line item appropriation, and for which a sum of money will be raised from anticipated receipts from the Town of Shelburne (pursuant to the operation agreement), as recommended by the Finance Committee in the Town of Buckland Fiscal Year 2022 Budget Report; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town raise and appropriate a sum of **\$333,743** to fund the operation and maintenance of the Shelburne Falls Wastewater Treatment Facility, an Enterprise Fund, for which a sum of money will be raised from anticipated receipts from the Buckland user assessment as a line item appropriation, and for which a sum of money will be raised from anticipated receipts from the Town of Shelburne (pursuant to the operation agreement), as recommended by the Finance Committee in the Town of Buckland Fiscal Year 2022 Budget Report.

**ARTICLE 14: CAPITAL AND/OR DEBT EXPENSES FOR THE SHELBURNE FALLS WASTEWATER TREATMENT FACILITY ENTERPRISE FUND**

To see if the Town will vote to raise and appropriate, borrow, or otherwise provide a sum of money, which is the estimated cost of [Capital and/or Debt Expenses for the Shelburne Falls Wastewater Treatment Facility](#), an Enterprise Fund, for which a sum of money will be raised from anticipated receipts from the Town of Buckland user assessment, as a line item appropriation, and/or the Buckland Enterprise Fund Retained Earnings as recommended by the Finance Committee in the Town of Buckland Fiscal Year 2022 Operating Budget Report; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town raise and appropriate a sum of **\$80,000** to fund cost of capital and/or debt expenses for the Shelburne Falls Wastewater Treatment Facility, an Enterprise Fund, for which a sum of money will be raised from anticipated receipts from the Town of Buckland user assessment, as a line item appropriation, and/or the Buckland Enterprise Fund Retained Earnings as recommended by the Finance Committee in the Town of Buckland Fiscal Year 2022 Operating Budget Report.

**ARTICLE 15: SPECIAL WASTEWATER TREATMENT FACILITY LINE ITEMS**

To see if the Town will vote to raise and appropriate, or otherwise provide a sum of money for the purpose of funding [Special Line Items in the Wastewater Treatment Facility Enterprise Fund](#) budget for Fiscal Year 2022, as line item appropriations, as recommended by the Finance Committee, in the Fiscal Year 2022 Wastewater Treatment Facility Budget Report, and, further to authorize that unspent amounts in said line items may be carried forward for use in following fiscal years without further appropriation; or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town raise and appropriate a sum of **\$800** to Special Line Items in the Wastewater Treatment Facility Enterprise Fund budget for Fiscal Year 2022, as line item appropriations, as recommended by the Finance Committee, in the Fiscal Year 2022 Wastewater Treatment Facility Budget Report, and, further to authorize that unspent amounts in said line items

may be carried forward for use in following fiscal years without further appropriation.

**ARTICLE 20: FUNDING SWIMMING POOL AT RECREATION AREA**

To see if the Town will vote to **Transfer the amount of \$150,000 from the Stabilization Fund** to fund the design and construction of a new swimming pool at the Buckland Recreation Area, including all costs incidental and related thereto; and further to authorize the Select Board to take all actions and enter into any agreements, including contracts in excess of three years, necessary to effectuate the purposes of this article; or take any other action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to appropriate from the General Stabilization Fund a sum of **\$150,000** to fund the design and construction of a new swimming pool at the Buckland Recreation Area, including all costs incidental and related thereto; and further to authorize the Select Board to take all actions and enter into any agreements, including contracts in excess of three years, necessary to effectuate the purposes of this article.

**ARTICLE 21: OTHER POST EMPLOYMENT BENEFIT7**

To see if the town will vote to raise and appropriate or transfer from available funds a sum of money to be deposited in the [Other Post Employment Benefits Liability Trust Fund](#) in order to offset future health insurance costs for retirees, or take any action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to appropriate from Free Cash the sum of **\$20,000** to be deposited in the Other Post Employment Benefits Liability Trust Fund in order to offset future health insurance costs for retirees

**ARTICLE 22: AMENDMENT TO SHORT TERM RENTAL TAX**

To see if the Town will vote to amend its acceptance of Section 3A of chapter 64G of the Massachusetts General Laws permitting the regulation of short term rental properties and established local excise tax of the occupancy of a room in a bed and breakfast establishment, hotel, lodging house, short-term rental or motel located within the Town of Buckland from a [rate of 5 percent to a rate of 6 percent](#) of the total amount of rent for each such occupancy; or take any other action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to amend its acceptance of Section 3A of chapter 64G of the Massachusetts General Laws permitting the regulation of short term rental properties and established local excise tax of the occupancy of a room in a bed and breakfast establishment, hotel, lodging house, short-term rental or motel located within the Town of Buckland from a **rate of 5 percent to a rate of 6 percent** of the total amount of rent for each such occupancy.

**ARTICLE 23: BYLAW AMENDMENT -- REVOLVING ACCOUNTS**

To see if the Town will vote pursuant to the provisions of G.L. c.44, §53E½, as most recently amended, to (1) establish the following revolving funds and fiscal year spending limits as set forth below, and further (2) to **amend the General By-laws** by inserting a new subsection within Chapter V, Financial Affairs, to be titled “Revolving Funds”, establishing various revolving funds, specifying the departmental receipts to be credited to each fund, the departmental purposes or programs for which each fund may be expended, and the entity authorized to expend each fund, such bylaw to provide as follows:

**Revolving Funds**

Sec. 6 A. There are hereby established in the Town of Buckland pursuant to the provisions of G.L. c.44, §53E½, the following Revolving Funds, from which the specified department head, board, committee, or officer may incur liabilities against and spend monies from without appropriation in accordance with the limitations set forth in this by-law.

B. Fringe benefits of full-time employees whose salaries or wages are paid from the fund shall also be paid from the fund.

C. No liability shall be incurred in excess of the available balance of the fund.

D. The total amount spent during a fiscal year shall not exceed the amount authorized by Annual Town Meeting or any increase therein as may later be authorized by the Select Board and Finance Committee in accordance with G.L. c.44, §53E½.

E. Interest earned on monies credited to a revolving fund established by this by-law shall be credited to the General Fund.

**ARTICLE 25: TOWN CLERK – COLLECTION OF RECEIPTS**

To see if the Town will vote to amend the Town’s General Bylaws, Chapter V, Financial Affairs, Disposition of Departmental Receipts, Sec. 4, as follows, with the struck through language deleted and the bolded and underlined language inserted:

Sec. 4. ~~Every officer shall pay into the treasury of the town all amounts received by him on behalf of the town, except as otherwise provided by law, and shall make a true return thereof to the Town Treasurer, stating the accounts upon which such amounts were received.~~ **Notwithstanding any General Law to the contrary, every town officer shall pay all fees received by them by virtue of their office into the treasury of the town and shall make a true return thereof to the Town Treasurer, stating the accounts upon which such amounts were received.**

Or take any other action relating thereto.

**Motion:** Ms. Moderator, I move that the Town vote to amend the Town’s General Bylaws, Chapter V, Financial Affairs, Disposition of Departmental Receipts, Sec. 4, as follows, with the struck through language deleted and the bolded and underlined language inserted:

Sec. 4. ~~Every officer shall pay into the treasury of the town all amounts received by him on behalf of the town, except as otherwise provided by law, and shall make a true return thereof to the Town Treasurer, stating the accounts upon which such amounts were received.~~ **Notwithstanding any General Law to the contrary, every town officer shall pay all fees received by them by virtue of their office into the treasury of the town and shall make a true return thereof to the Town Treasurer, stating the accounts upon which such amounts were received.**

**ARTICLE 26: BYLAW CHANGE – ANIMAL CONTROL**

To see if the Town will vote to amend the Town's General Bylaws, Chapter XI, Dog Bylaws by deleting Sections 1 through 6, in their entirety and creating a new Chapter XI, Animal Control Bylaws to read as written in [Attachment A](#) of this warrant; or take any other action relating thereto.

**ARTICLE 27: PIONEER VALLEY MOSQUITO CONTROL DISTRICT**

To see if the Town will vote to become a member in the [Pioneer Valley Mosquito Control District](#) pursuant to Massachusetts General Laws Chapter 252, §5A and other applicable sections of said law; and to meet this obligation, raise and appropriate the sum of \$5,000 from taxation to fund the annual membership fee or, take any other action relative thereto

**Motion:** Ms. Moderator, I move that the Town vote to become a member of the Pioneer Valley Mosquito Control District pursuant to Massachusetts General Laws Chapter 252, §5A and other applicable sections of said law; and to meet this obligation, raise and appropriate the sum of \$5,000 from taxation to fund the annual membership fee

**ARTICLE 28: PETITION ARTICLE – STREET LIGHTING**

To see if the Town will vote to amend the Town's Bylaw by adding a new section, Chapter XVI Public Street Light Standards"

- a) Purpose. This change would be consistent with proposed 2021 Massachusetts bill "An Act to improve outdoor lighting, conserve energy, and increase dark-sky visibility". Research shows that excessive night lighting harms the environment in many ways. It has been estimated that Massachusetts wastes 1½ billion kilowatt-hours of electricity and \$180,000,000 annually from wasted light that is needlessly shown upward into the sky or beyond the intended purpose. Visual impairment occurs when poorly designed lighting causes harsh glare that blinds and distracts drivers, especially in bad weather and for elderly drivers with poor visibility. Environmental consequences occur when over lit buildings and streets disorient many birds, especially during their seasonal migrations, causing death due to impact or predation. Loss of the starry sky occurs when sky glow from light pollution reduces enjoyment of the night sky. Lighting professionals recognize that the most straightforward means to create a glare-free nighttime environment is to utilize fully-shielded lighting fixtures, which emit all of their light down (below horizontal) and none of it directly up into the sky. White LEDs are strong sources of blue-rich light, which has several negative side effects including more disruption to the circadian activity of nocturnal wildlife, as well as for humans. Lower K lights are warmer and less disruptive. Our current lights are 3,000K. the maximum considered by the legislation.

2200K is similar to the lights we had before. (Information obtained from the authors of the bill).

- b) Chapter XVI Public Street Light Standards - As of the date of the vote by the town on this article, the town will provide all existing public LED street lights with house-side shields. The town will dim all lights to 50% at all times. All future public LED street lights installed or

replaced in the town will be 2200K and will be fully shielded fixtures. "Fully shielded fixture", is a fixture that in its mounted position has an upright value of UO as defined by the Illuminating Engineering Society's standards publication TM-15-20 (Luminaire Classification System for Outdoor Luminaires);

or take any other action relating thereto.

## **ARTICLE 29: PETITION ARTICLE – FILMING PERMISSIONS**

To see if the Town will vote to amend the Town's Bylaw by adding a new section, "Chapter XVII Allowing Filming in Buckland"

- a) Purpose: Residents are concerned about how decisions are made related to major television and motion picture filming that takes place in Buckland. The average resident is not a business owner, and business owners may or may not benefit from filming. Rather residents are generally not compensated for inconveniences including not being able to walk or drive through the town and neighborhoods at uncertain times, lighting that effects large areas of town, generators running, loss of parking, loss of access to stores and other businesses that serve important needs, and film production contents that are offensive to the values of many residents. This action would require the Select Board to consult with residents in a formal setting and with public notice. It would allow the residents to decide whether or not a film can take place in the town.
  
- b) Chapter XVII-Allowing filming in Buckland - Before the Select Board or its designee(s) agrees to allow television or motion picture filming, and other comparable activity, or enter into a contract with any such filmmaking, the Select Board shall present the project at the town at Annual Town Meeting or at a Special Town Meeting. Registered voters will vote on whether to allow the filming to occur in the Town;

or take any other action relating thereto.

You are directed to serve this warrant by posting attested copies thereof at the Post Office, the Public Library in Buckland Center and Buckland Town Hall, 17 State Street, in said Town, seven days at least, before the time of holding said election and meeting.
