Covid-19 Vaccination Clinic: As many of you are aware there will be a flu vaccine clinic at Mohawk Regional High School tomorrow and Saturday. The clinic is sponsored by the Franklin Regional Council of Governments and is expected to vaccinate over two people per day. More information is available at FRCOG.org or on the Town of Buckland's website. We would like the Select Board's permission to use the Black Board connect system (Reverse 911) to alert residents of additional clinics in our area. Since the information is coming to us at irregular times and will require almost instant reaction time, we are looking for blanket approval for a 30-day period. Thanks to our local emergency management and our local health officials for all their hard work to make this happen.

Upcoming Highway & Bridge Projects: For those of you that subscribe to the website notification service you should have received an email today to let you know about a new feature on the highway department page. We have created a Current Projects section that has a drop-down menu and a list of all the upcoming infrastructure improvement projects in the pipeline. There are engineering plans, contract documents and grant information. We encourage residents to refer to these pages regularly as we will use them to communicate project updates and milestones. If there is any information that is not on the site that would be helpful please let us know and we'll do our best to add it.

MassDOT Chapter 90: Speaking of road repair we received our annual Chapter 90 notice. We will receive \$184,000. As you know we use this money for engineering and for grant match to pursue bigger projects.

Town Clerk: Our new Town Clerk Karen Blom started work today. She spent her first day getting settled in the office and catching up on email and phone messages. She is a quick study and will the office be running smoothly in no time. Elizabeth left things in perfect order and her notes and instructions are very thorough. I am sure they will be helpful to Karen as she goes along.

Elected Officials Resignations: Two elected officials have stepped down from their posts, Terry Estes from the Board of Health and Karen Blom from Finance Committee. I had wanted to get a handle on how long both had served on these committees, but it was one of those days. I believe they are both in the several decade categories and they will be difficult to replace. Both positions are eligible for immediate appointment should someone step forward. We will need to update our election warrant to include those the positions.

GOTR: The Buckland Recreation Committee has entered into an agreement with the Girls on the Run Organization which will begin this Spring. Coaches are still needed, no experience necessary.

Hi Terry

I have talked to both Peggy and Marti and I think you all are on the same page.

To move forward:

- 1. Terry would submit a letter resigning the BOH seat. If this happens before Tuesday night I will make the announcement at that evening's SB meeting and ask that anyone interested in an interim appointment contact the Board with a letter of interest.

- 3. I will add the item to the SB agenda for the March 9th meeting. Presumably the appointment would be made that night.
- 4. Also the SB will need to add the unexpired position to the May 4th Election Warrant.
- 5. If it's Peggy's intention to finish serving Terry's unexpired term she will need to take out nomination papers for the seat. Available now through the middle of March. I'll get the exact date for you on Monday.
- 6. It's worth noting that another resident(s) could come forward with hopes of serving as either

the appointed interim or the elected unexpired term.
