We want to thank you, our residents, our business owners and our guests for the two week imposition on your daily lives.

We know not everyone is a fan of Dexter and his Code and some of you would just as soon never experience the delays and detours caused by the weeks of prep and then the weeks of filming. Others, hopefully the majority, enjoyed the distraction from winter, made longer by the pandemic's forced hibernation.

We were pleased that the Marble crew adhered to a strict Covid-19 protocol, allowing those who wished to venture out and watch some of the filming do so without great risk or exposure. Did you know that each person associated with the production was tested twice a day? One 48 hour test and one rapid test.

There have been questions about how much money the Town of Buckland "made" from the experience. The Buckland Select Board signed a contract with Marble Productions for a base rate of \$20,000. That fee covered the use of the Town's public spaces, including parking. The production company also paid the Town \$500 per week rent for the upstairs at the Town Hall. Additional costs associated with Police, Highway, Health and Fire will be billed separately.

What we do with this money will be somewhat up to you. The Select Board will likely add an article to the Annual Town Meeting warrant to create a special revolving account for film & media related permit fees. The monies collected in this account would be use for improvements to the village area. Have some ideas? Send them along!

## REGIONAL HEALTH NOTES

### WHAT YOU NEED TO KNOW ABOUT THE COVID-19 VACCINE

**Where are we?** Massachusetts is in the final Phase of the Vaccine rollout – Starting Monday, April 19th anyone 16 years and older are eligible to receive vaccine. To see the progression of the phases, go to: <https://www.mass.gov/info-details/massachusetts-covid-19-vaccination-phases>

### WHERE TO GET VACCINATED

There are many places to [schedule a vaccine appointment](#). Vaccine supply is limited, but we expect availability will increase over the upcoming weeks.

Those able to travel are encouraged to schedule appointments at the High Volume Vaccination Sites at [UMass Amherst](#) and [The Eastfield Mall](#) in Springfield.

Pharmacies, like [CVS](#) and [Big Y](#), are accepting appointments through their websites.

Franklin County Doctor's Offices and Health Centers are scheduling appointments with their patients when they have vaccine, though there is very little vaccine going to primary care practices at this time. Please do not call about vaccinations, when one is available they will call you to schedule an appointment.

Local Clinics are open throughout the county as part of a state approved regional collaboration. These clinics intended to support Franklin County residents and are a coordinated effort between many stakeholders in our region. Greenfield maintains a weekly clinic and FRCOG clinics are rotating between Deerfield, Bernardston, Buckland, and Montague (sites and locations may change based on vaccine availability and other factors). Times, dates, locations, and private registration links for upcoming clinics are posted Monday morning and released in coordination with our regional partners.

# Town Meeting Feb 13, 2021—11 am



Buckland will hold the Annual Town Election on **Tuesday, May 4, 2021 at 10 a.m. to 8 p.m.** at the Buckland Town Hall, 1 William Street. Check out the [ballot](#) here.

In addition to choosing representatives to serve on the Select Board, Finance Committee, School Committee and other important elected boards and committee voters will be asked to vote on a ballot question that references a 2018 Annual Town Meeting.

*Question One: Shall the Town of Buckland be allowed to exempt from the provisions of proposition two and one-half, so called, the amounts required to pay the town's share of the bonds issued to pay for repair work to the Buckland Shelburne Elementary School, to include asbestos abatement and floor replacement totaling \$230,000, as voted at the May 9, 2018 Annual Town Meeting?*

This is not a typo. In 2018 those residents who attended the Annual Town Meeting voted to approve an article to borrow \$230,000 for improvements to the Buckland Shelburne Elementary School. The vote was contingent upon the amount being [debt excluded](#) which means the Town could borrow the money but would not have to pay the annual payments within the restrictions of Proposition 2 1/2. The Town had 90 days to bring this same question before voters in a town election to affirm the Town Meeting Vote. Unfortunately we never took that step and never realized the step had been missed until the money was borrowed, the work was completed and the bills needed to be paid. Because we had missed putting the question on the ballot the state would not allow us to debt exclude the amount and we had to raise the money within the confines of our general budget.

The Department of Revenue has reviewed our situation and has determined that we can put the question back on the ballot now, as it is clear that the money has already been approved and spent by MTRSD. If supported by you, the voter, we will be able to exclude the debt from our general budget as originally approved by Town Meeting.

### Clinic Locations:

**TURNERS FALLS** Saturday, April 17th 2021 10am-12pm Franklin County Regional Dog Shelter 10 Sandy Lane, Turners Falls, Ma 01376

**HEATH** Saturday, April 24th 2021 10am-12pm Former Heath Elementary School 18 Jacobs Road, Heath, Ma 01346

**SHELBURNE FALLS** Saturday, April 24th 2021 1pm-3pm Shelburne Falls Fire Department 121 State Street, Shelburne Falls, Ma 01370

Due to COVID-19 this clinic will be for a rabies vaccination only. No other veterinarian services will be offered at this time. **Cost: \$20.00 (CASH)** per vaccination. Payment Terms: Cash only. A mask or face covering **MUST** be worn. Social Distancing will be in place.

All dogs **MUST** be on a static leash. Flexi or extendable leashes are not allowed. All cats need to be in a carrier. No exceptions. Both 1 year and 3 year rabies shots will be available. To be eligible for a 3 year vaccine you will need to provide proof of a previous 1 year vaccine.


