There were ninety-eight (98) Town of Buckland registered voters in attendance (quorum being 7) at the Annual Town Meeting held in the parking lot of the Mohawk Trail Regional School. Phoebe Walker served in her capacity as Moderator working from a warrant dated June 15, 2020 and posted by Constable, Floyd Scott.

The meeting was called to order at 10;01am. The Moderator welcomed everyone to the meeting and went over the rules of Town Meeting and explained the booklet that voters received when they checked into Town Meeting. Select Board chair, Zachary turner read the dedication of the Annual Town Report that was dedicated to Arthur "Henry" Phillips.

Senator Adam Hinds and Representative Natalie Blais were in attendance and presented citations from the Senate and House of Representatives to retiring Town Clerk, Janice Purington in recognition of her 30 years of service as Town Clerk for the Town of Buckland.

1. CONSENT MOTION:

The Town <u>voted and passed unanimously</u> to take Articles 1, 2, 5, 11, 12, 13, 14 & 15 out of order in this warrant and approved the motions below as one vote without debate:
