All dogs that have attained the age of six months or older shall be licensed annually by March 31<sup>st</sup> of each year. New dogs over 6 months must be licensed within 30 days of residence in Buckland. The primary reason for licensing dogs is for public safety. No dog can get a license without first having a rabies vaccination, required at 6 months of age and beyond. **All dogs unlicensed after March 31<sup>st</sup> are subject to an additional \$25 late fee.** The town's animal control officer obtains a listing of all registered, and known, unregistered dogs yearly. Yearly enrollment is between Feb 1<sup>st</sup> and March 31<sup>st</sup>.

## Please note:

- 1. Penalties for violations are governed under MGL Chap. 140 Sec. 173A. Fines are \$50-500 based on offense count (50, 100, 300, 500 subsequent = 500).
- 2. Complaints concerning dogs should be made to Animal Control under MGL Chap. 140 Sec. 157; Telephone Number is 413-768-0983
- 3. All dogs that have attained the age of six months or older must be vaccinated against Rabies. A copy of the Rabies certificate must be enclosed.
- 4. If applicable, copy of proof that dog has been altered must be presented with application.
- 5. If your dog is picked up by the Animal Control Officer and brought to a kennel, you pay the base fee of \$20/day.
- 6. After March 31<sup>st</sup> a late fee of \$25.00 is added to the license fee.
